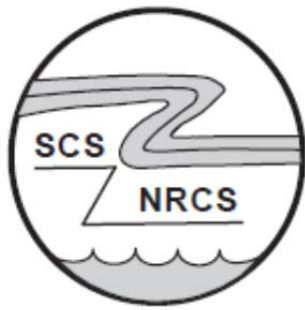

## NOTES FROM THE POTOMAC

**Congressional Actions** – Congress “To-Do” List includes deficits, budget, tax cuts, sequestration, [2012 Farm Bill](#) (S.3240), statutory limit on public debt, and other critical issues needing Congressional action. Hopefully, some of these will be acted upon after the election and before the start of a new Congressional session in 2013. The impact of sequestration kicking in is the most important concern of all government agencies.

**Fiscal Year 2013 budget** – Congress and President Obama may agree to a "Continuing Resolution," a big hurdle for avoiding a September 30, 2012 government shutdown, with the agreement resulting in a 6-month extension of current spending priorities until April 2013. One Washington interpretation is that this is "just kicking the can down the road" rather than addressing the real budget needs.

**House and Senate continue to pass legislation impacting Federal employees** – The White House imposed a 2-year pay freeze and is extending it through spring of 2013. House Republicans are pushing for an extension ([H.R.3835](#)). [H.R.828](#) would give agencies the authority to fire employees who are delinquent in paying their federal taxes. Numerous other bill proposals have been introduced in the House, all affecting career employees.

**Phased Retirement Option** – Federal employees will soon have the option to ease into retirement toward the end of their career by working part-time and collecting an annuity ([P.L. 112-141](#), Sec. 100121). Signed into law July 6, 2012.

**Farm Bill's Food Fight** – The big difference between the House and Senate versions of the 2012 Farm Bill is the Supplemental Nutrition Assistance Program (SNAP) or Food Stamps Assistance. The House Ag. Committee cut more than \$16 billion, while the Senate cut about \$4 billion. SNAP now takes up about 80% of farm bill appropriations.

**Estate Tax Changes** – Be Prepared. Currently the federal estate tax exemption is \$5 million per person and \$10 million per married couple. Any wealth above that is taxed at 35%. This exemption expires at the end of this year. If Congress does not renew the current law or enact a new law, the federal estate tax exemption will be reduced to \$1 million per person with a top tax rate of 55%. If this happens, many feel this will be devastating to farm owners and small businesses.

## FROM THE PRESIDENT

It seems like just a few days ago we were in Fort Worth, Texas attending our Annual Meeting that was held in conjunction with the Soil and Water Conservation Society's Annual Meeting. Our annual Meeting consisted of three main parts: Our Luncheon, Board of Directors Meeting and attending some of the SWCS sessions.

Our Luncheon was attended by approximately 40 members. While we had many special guests, most noteworthy was **Mel Davis**, former Administrator for the Soil Conservation Service. The Luncheon was at the REATA Restaurant which was about a block away from the hotel where the meetings were held. I want to thank **Willeene and Arnold King** for selecting the restaurant. The food was great and it was not at typical hotel prices. Arnold is the ARCSE South Regional Vice President, and he also served as Luncheon host. **Tom Christensen**, NRCS Regional Conservationist, gave us an excellent presentation of what is current with the Natural Resources Conservation Service. **Bill Boyer**, SWCS President and **Jim Gulliford**, SWCS Executive Director, updated us on what is current with SWCS. **Mike Nethery**, who served for 10 years as our newsletter Editor, was given a Meritorious Service Citation in Special Recognition and Appreciation for Ten Years of Dedicated Service to the ARCSE Members as Editor of an Outstanding Newsletter.

The Board of Directors meeting:

- Ron Marlow reviewed the financial status of ARCSE. He reported that expenses for FY-12 exceeded income by \$2,837 and that expenses have exceeded income for eight of the past nine years. He also reported that the FY-13 planning budget at the current rate of income shows that expenses will not exceed income. The savings realized with E-news appears to be just about what we need to balance the budget.
- A concerted effort will be made this year to recruit State Representatives in the following states where we have vacancies: AK, AL, AZ, FL, PR, WI, WY, CT/RI, and MS.
- A proposed revision to the Awards Policy is being drafted and will be presented to the Board during our next teleconference.
- The Board of Directors decided to hold at least one teleconference with their State Representatives this year.
- A concern was raised regarding political statements being sent to the Editor for publication in the Newsletter. After discussion, the Board of Directors took the following position: **"Although we believe in free speech, the Board believes that the ARCSE newsletter is not an appropriate venue for sharing one's political leanings."** The Board took the position that the ARCSE Newsletter will remain politically neutral and have asked our editor to remove anyone's comments relative to partisan politics.
- Upcoming Annual meetings:  
2013: Reno, NV (Peppermill) - July 21-24  
2014: Chicago, IL (Westin Lombard, western suburbs) - July 27-30

Several of our Members attending the meeting said that they appreciated the opportunity to also attend several of the SWCS sessions.

**Cecil Currin** wrote this very nice note to NE State Representatives about the Annual Meeting:

"Fort Worth is a good place for a gathering in spite of the heat. **Lou** and I drove from the St. Lawrence River leaving a temperature of 70 degrees. When we drove into the city, the car thermometer registered 107. Texas does have good air conditioners. We enjoyed a night of dancing at Billy Bob's honkytonk and had excellent Mexican food and barbeque. We found an enormous watermelon in Arkansas (at least 50# and it was delicious) and a great home cooking buffet in Jackson, TN. There were 18 vegetables plus a huge salad bar and dessert bar. The trip went well and we traveled over 4,000 miles.

I can report that ARCSE leadership is doing an excellent job. President **Mark Berkland** is also on the SWCS board of directors which gives us a nice relationship with our cohost for the annual meeting. Mark has initiated regular teleconferences for the ARCSE Board. This had made the annual face to face meeting more efficient.

Our most important business for this year has been the process of moving to the Enewsletter. With the change to a paragraph form the newsletter is much more readable and has gained wide acceptance. The paper copy will continue to be available to all members who request it. The savings realized with Enews appears to be just about what we need to balance the budget.

Prior to the meeting **Peg Reese** from West Virginia asked that we discuss a way to get a list of retirees from NRCS through the HR staff. We did discuss this and it appears that "Privacy Laws and Policy" makes this impossible. The best way seems to be informal contacts with friends in the State Office. There is usually an employee organization of some kind in the state offices and the organization often announces parties or coffees for retirees. Some even have a newsletter and one can get on an email list which is nonofficial.

There were no awards presented this year. We all need to think of those ARCSE members who do outstanding community work or provide outstanding leadership within the organization.

The luncheon was offsite in a very good Mexican restaurant just a few steps from the hotel. It was quite reasonable and delicious. Most of us have tired of a dried out chicken breast hotel lunch. ## A BIT OF HISTORY

From about 1986 onward to my retirement at the end of 2011, my office was on the sixth floor, first wing of the South Building, bracketed to the north by the Conservation Engineering Division and to the south by the Ecological Sciences and Social Sciences Division. All the specialists were a few steps away and I peppered them with questions. One of the pleasures of working as historian for SCS and then NRCS was the multi-disciplinary nature of the work. The agency was not dominated by one science or discipline as a number of other Federal agencies were. In writing history, this situation was both a blessing and a curse. It provided variety in the history work; yet it required more background research on the disciplines.

**Curtis Sharp**, National Plant Materials leader, was one of the people who helped me, and now I help him occasionally on his history project. He and **Jack Carlson** are collaborating on a history of the plant materials program. I have long regarded that program as one of the jewels and major contributions of the agency. The early nursery specialists who came from the fields of agronomy, forestry, and wildlife ecology virtually created the field of selecting and propagating plants for conservation uses. Usually they tried to find plants that served multiple purposes such as erosion control, soil improvement, wildlife food and habitat, animal forage, beautification, and ecological preservation. As the commercial viability of providing plants for conservation uses became more obvious, SCS, with strong direction from Congress, relinquished the nursery function, and at the same time strengthened the identification and selection of plant materials.

By this point, it's becoming obvious that I am preaching to the choir. We look forward to seeing Curtis' and Jack's history, which will bring greater understanding and appreciation to this major conservation contribution.

It was a pleasure to prance through the garden, as Margy Gangl did, with the pail of soapy water and drown those suckers. I cut back the Four O'Clocks, sprayed them with "Eight" and they have come back and are ready to bloom. Down with the Beetles!! (But they have attacked the neighbor's blueberry bushes.) They appear once in a while on the pea pods and some marigolds, but I picked them off. They seem to be very picky (thank heaven) about where they set up camp.

I turned 80 on Flag Day (now you know why you've been flying that flag on June 14<sup>th</sup>) and my kids put on a grand party, inviting nieces, nephews and friends that I haven't seen in a long time. Of course, lots of good food.

**John Handler** sent in some 'news' some time back when we did not have a Newsletter submission. John's article is so interesting that I am publishing it here:

"Well, two years into retirement, I have no regrets, and no reason to have them. As I stated last year, why didn't I retire sooner? Travel seemed to be the theme this past year, with six experiences squeezed into the past 12 months. It all started with a transcontinental trip last February: I had always wanted to visit the Rocky Mountains in winter (from ground level, not just a fly over at 35,000 feet), but not having a passion for skiing, no wishing to drive through them

during the winter season, I needed an excuse to see them. So how about a train trip? And to make the experience even more 'wintry', I crossed the continent on VIA Rail (Canada's passenger rail system)."

"Starting from my 'home' Amtrak station in Red Wing, Minnesota, I traveled east to Buffalo, New York, then from Buffalo to Toronto, then west across Canada (Toronto to Vancouver), then from Vancouver to Seattle, and then east again from Seattle back to Red Wing – it is possible to make a complete 'circle tour' on passenger trains. (OK, technically, I didn't actually see the Atlantic Ocean, but crossing Canada was a 4,466-mile adventure in itself, so it seemed "transcontinental" – Canada is a huge country!)"

The most impressive views were from the bombardier's seat, right in the nose of the plane completely surrounded by glass. Unfortunately for the Liberty Belle, she developed an in-flight engine fire the week following my flight, safely landed in a farm field, but was consumed by the fire."

"In July, the Lewis and Clark Trail Heritage Foundation had their annual meeting in Omaha, and being a Lewis and Clark aficionado, it was enjoyable to relive the Corps of Discovery's journey through the Omaha area through re-enactors."

"And, as long as I was in Omaha, I headed west to see the Nebraska Sand Hills, which I had heard a lot about over the years, but had never visited, except briefly near North Platte. Driving through them on Nebraska Route 2 was memorable (did you know that there is a National Forest – yes, with trees – in the Sand Hills?). When I arrived at "Carhenge" on the western side of the Sand Hills (Carhenge is North America's answer to Stonehenge), I knew my journey was complete."

"But wait . . . as long as I was in the Sand Hills in western Nebraska, why not see where all those coal trains come from (i.e., Eastern Wyoming)? The coal mining and railroad operations in the Powder River Basin are quite impressive – mining and railroading on a scale I had never seen before."

"On August 19, the Closing Ceremony for SCAM was scheduled. Not familiar with that acronym? It stands for the Soil Classifiers Association of Michigan, and while its Closing Ceremony wasn't of Olympic proportions, to the SCAM members it was that big of a deal, sad to see the society disbanding. However, the intent of this last meeting backfired – attendance (dwindling for several years previously) was way up, so much so that the members voted to not disband. SCAM lives on."

Payments for leasing of land for a five or 10 year period has increased drastically in the past couple of years to \$5,800 per acre plus 20 percent royalty on one of the more recent signings. One hundred permits have been issued by the Ohio Department of Natural Resources to drill in Carroll County. Nine wells are in production. The "fracking" is being done about 9,500 feet below the surface in the Carroll County area. The pipelines are not in place to move the oil and gas, and processing facilities still must be constructed, so some of the new high production wells cannot go into immediate production. Another big problem is where can the hydraulic fracking companies obtain the seven to eight million gallons of water needed to frack one well.

***Editor's note:** Fracking is very controversial, and individual state regulations vary, but from a natural resources standpoint, remember that it's not just about chemicals and their potential impact on groundwater, but also the tremendous volumes of water needed to "drive" the fracking process. The potential impacts on the quantity and availability of surface and groundwater resources are also an important local natural resource conservation issue where fracking is employed. In addition, also remember that the special gradations of sand needed for the fracking process to work, to hold the fractured rock open after fracturing, also need to come from somewhere; i.e., huge surface mines that disturb the landscape. So the point is that "fracking" has many natural resource conservation aspects, both surface and subsurface.*

**LARRY W. CALDWELL, P.E.**, is the recipient of the ASABE 2012 G.B. Gunlogson Countryside Engineering Award for his outstanding contributions and engineering service in the rehabilitation of aging watershed dams for the protection of natural resources and general public. Caldwell is a nationally recognized authority on dam safety and dam rehabilitation. He served NRCS for more than 41 years and is well-known for providing support for congressional efforts to obtain USDA authorization to assist communities with rehabilitation of aging watershed dams. This legislation created the NRCS Watershed Rehabilitation Program, for which Caldwell was named the first national program leader. He managed a budget of \$86 million, which provided funding for 118 rehabilitation projects in 20 states during the first five years of the program. Since 2000, more than \$300 million has been appropriated for the rehabilitation of 230 dams in 29 states, with Caldwell providing direct assistance on 185 of those projects.

## SENIOR CONSERVATIONIST CHRONICLE

### Senior Conservationist, Cecil Martin

Cecil is a recent addition to the honorable list of Senior Conservationists. He was born and raised in Elberton, Georgia (GA), where he also graduated from high school in 1943. After high school, he served in the U.S. Navy as an aerial gunner on a torpedo bomber. After WW II, in 1946, he started college under the GI Bill. He met Eugenia (Gene) Mitchell during his freshman year. They were married on April 16, 1948. He graduated from the University of GA with a BS in Ag Engineering in 1952.

Cecil's career with SCS began immediately after graduation in Clarkesville, GA, as he became the Project Engineer for what was to become the first PL-566 (pilot) watershed project. Beginning his upward career movement, in 1956, he became Area Engineer for 26 counties in GA. In 1958, he was promoted to State Design Engineer in GA, supervising a design staff and a geologic site investigation staff.

His accomplishments as State Design Engineer are many, including having designed over 300 floodwater retarding dams, some over 100 feet high. Many of the dams contained additional water for recreational and municipal uses. There were many county recreation parks and stream channel stabilization measures, including one urban-area reinforced concrete-lined channel in Columbus, GA. It has water control structures based on hydraulic model studies made at GA Tech and still exists today.

In 1973, Cecil became the State Construction Engineer in Georgia. He retired from SCS in 1987 as Assistant State Conservation Engineer. He also retired from the US Air Force Reserve as a Civil Engineer (Major) in 1986.

Cecil received numerous job performance awards throughout his career with SCS. One rather unique award came from the Athens Junior Chamber of Commerce, when he was awarded their "Boss of the Year." He also was a registered Professional Engineer and active in professional and civic organizations. Cecil has been a valuable asset to his church, Watkinsville First Baptist, as a member of Deacons and Chairman of Deacons. He served on several church building committees, including one that involved moving the church from downtown Watkinsville to a lovely new facility in a rural setting just east of the downtown area.

After retiring Cecil did engineering consulting work for about 4 years. Also, he served on a Water Task Force which developed a plan for a 4-county municipal water dam and reservoir which is now in operation.

Cecil and Gene have 5 children, 20 grandchildren and one great grandchild. They have enjoyed their travels and experiences and are currently enjoying retirement on their farm in Oconee County, Georgia. This is where Cecil has raised Angus beef cattle and hay since 1964.

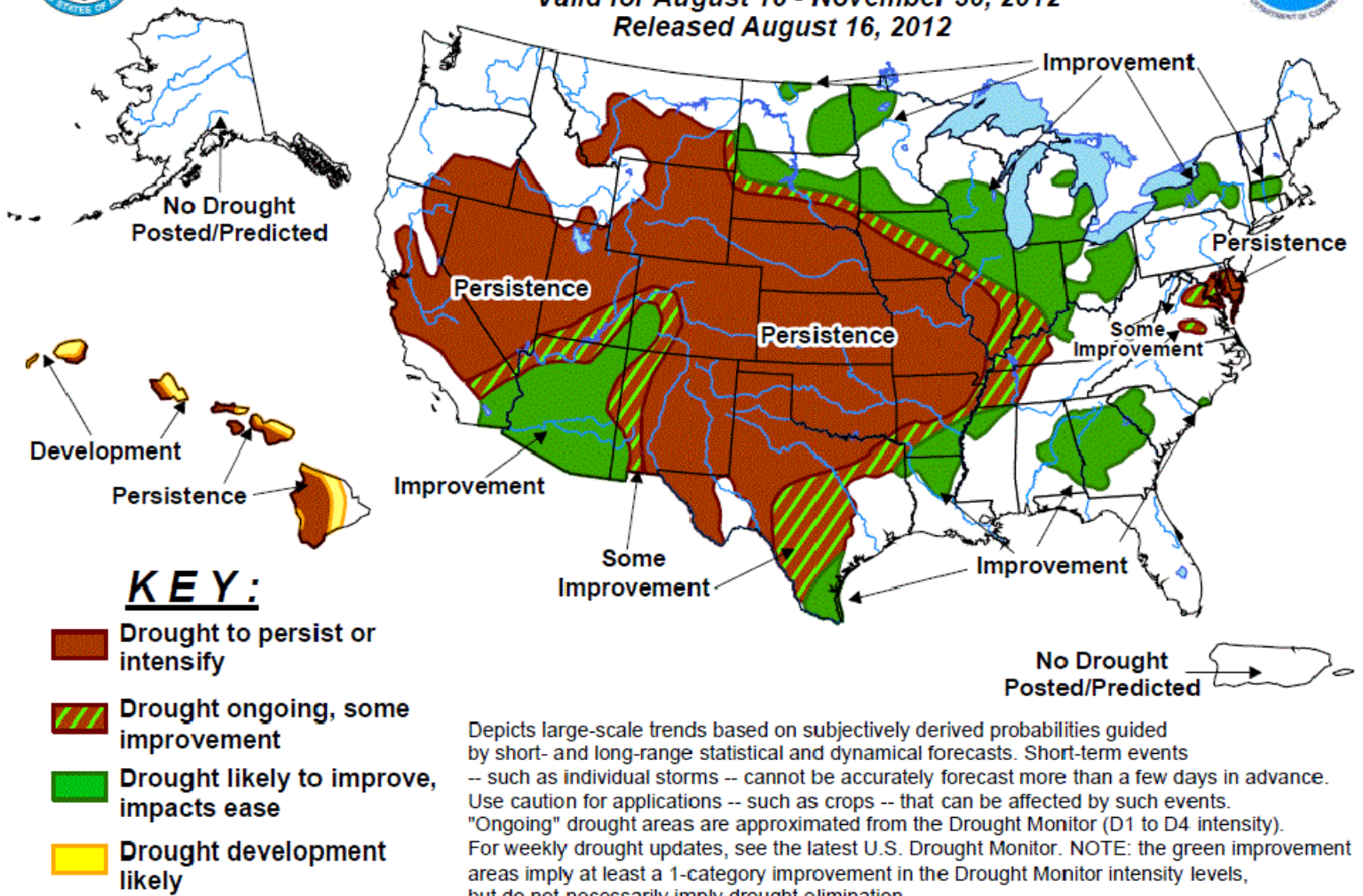
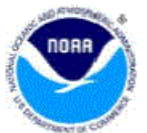
